## Adobe LiveCycle® Rights Management ES Server

Administrators can set document privileges and apply security policies by creating Policy Protected PDF files created at the device or even after document creation, utilizing the Adobe LiveCycle® Rights Management ES Server.

This enables administrators to encrypt files and apply persistent and dynamic policies that help maintain confidentiality and control use. Each recipient's use of sensitive information, including when and how often a file is accessed, can also be monitored through detailed audit logs.


These policies are persistent and are part and parcel of an organization's data governance and data loss prevention strategy. Business-critical information is protected, providing greater assurance that recipients can interact with information in pre-authorized ways, helping to prevent inadvertent or malicious disclosure of sensitive or confidential information.

#### How it works

Once a Policy Protected PDF document is created on an imageRUNNER ADVANCE device, upon attempt by a user to open the protected PDF, the Adobe Reader will contact the Rights Management Server to check the latest authorized users, expiration, auditing and watermarking policies set by the administrator. These latest policies will then be enforced by that application to ensure the information in that document remains secure.

## Full, up-to-date protection throughout the information lifecycle

This feature allows protected access to documents throughout the information lifecycle. It also permits policy-based enforcement and dynamic policy control of documents that have been created in the past. This feature can also ensure that only the latest documents are used or in circulation. Lastly, system administrators have the ability to revoke access to documents by former employees, former business partners, or contractors to protect critical information.

### Requirements to note:

To be able to generate a PDF linked with Adobe LiveCycle® Rights Management ES, the Adobe LiveCycle® Rights Management ES must be licensed and pre-configured by a system administrator and the imageRUNNER ADVANCE device must be connected via the intranet or internet. The following PDF file formats are not compatible with Adobe LiveCycle® Rights Management ES: PDF/A-1b and Encrypted PDF.
